Continual Improvement

We will ensure that all project personnel are given the necessary training and advice to implement measures to protect ecosystems, sensitive sites, protected species, nesting sites, migrations, plants, birds, fish and wildlife.

Exceeding Statutory Requirements

We will comply with all applicable environmental legislations, operate within strict guidelines in line with local and federal governing bodies, fisheries, agencies and authorities and exceed these requirements where appropriate through voluntary participation in government, industry and community programs.

Employee Training and Awareness

We will provide training, instruction and procedures in accordance with our Environmental Management System. We will take steps to ensure that all staff, contractors and consultants are aware of our obligations and commitments to operate in an environmentally responsible manner and reduce potential impacts on wildlife and sensitive sites. We will provide the necessary training in safe storage, working with hazardous materials, waste management, emergency contingency plans and habitat conservation.
